Pursuant to the Law on Trade Companies, the Statute of Makedonski Telekom AD - Skopje (the Company) and the Resolution of the Board of Directors of the Company (Arch. No. 139507/1 dated 26.02.2021), the Shareholders' Assembly of the Company, at its annual meeting held on 17 June 2021, adopted the following

Proposed Resolution

Article 1

The Controlling, Accounting and Tax Department shall organize the submission of the audited Financial Statements of the Company for the year ended 31 December 2020 in accordance with the adopted international financial reporting standards published in the "Official Gazette of the Republic of North Macedonia", together with the audit opinion, to the competent state institutions in accordance with the legal regulations.
